BY-LAW 829

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH, IN THE NORTHWEST TERRITORIES, TO AMEND THE GENERAL PLAN BYLAW #793 PURSUANT TO THE PROVISION OF THE PLANNING ACT R.S.N.W.T., (1988), C. P-7, S.29

WHEREAS, the Municipal Corporation of the Town of Fort Smith, in the Northwest Territories, has enacted a General Plan, Bylaw #793, in accordance with the Planning Act, and

WHEREAS, Council of the Municipal Corporation of the Town of Fort Smith has reviewed the General Plan, Bylaw #793 and decided to change certain sections to reflect current conditions:

NOW THEREFORE, the Council of the Town of Fort Smith, at a duly assembled meeting enacts as follows:

- Schedule 1, Conceptual Land Use Plan, forming part of and contained in the Town of Fort Smith General Plan Bylaw #793 is hereby amended as follows:

That the following parcel of land be re-designated from Future Urban Use (UR) to Industrial (M)

See Schedule "A" attached and forming part of this bylaw.
- This Bylaw shall come into effect on the date of its third reading.
