BY-LAW 837

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH, IN THE NORTHWEST TERRITORIES, TO AMEND THE LIVERY LICENSE BYLAW 603 PASSED PURSUANT TO SECTION 70 OF THE CITIES, TOWNS AND VILLAGES ACT, S.N.W.T. 2003,c.22

WHEREAS, the Council of the Corporation of the Town of Fort Smith, in the Northwest Territories, deems it to be in the public interest to amend the Livery License Bylaw 603.

NOW THEREFORE, the Council of the Town of Fort Smith, at a duly assembled meeting enacts as follows;

1. That Schedule 3 and Schedule 4 amending the Livery License Bylaw 603 are hereby replaced with a new Schedule 3 and a new Schedule 4 attached hereto and forming part of this bylaw.
2. That Bylaw 758 Schedule 3 is hereby repealed.

**TARIFF OF FARES**

Flag Rate (Includes GST).....	ELIMINATED
Additional 1/10 of a kilometer (includes GST).....	ELIMINATED
Charter within the municipal boundary.....	ELIMINATED
No charge for bags or luggage from stores Or to/from Airport.....	ELIMINATED
Any pick-up or delivery where no passenger is involved, meter fare plus.....	ELIMINATED
Limousine service between Airport and Town.....	\$10.00 per person

Operator's License.....\$12.00
4. Replacement of any License/Permit  
Issued under this By-Law.....\$6.00
