A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH, IN THE NORTHWEST TERRITORIES, TO AMEND THE CONSOLIDATED RATES AND FEES BYLAW 846 SCHEDULE "B" AMBULANCE FEES, PASSED PURSUANT TO SECTIONS 70 AND 72 e. OF THE CITIES, TOWNS AND VILLAGES ACT S.N.W.T, 2003, c.22.

WHEREAS, the Council of the Municipal Corporation of the Town of Fort Smith, in the Northwest Territories, deems it to be in the public interest to make changes to the Ambulance fees;

Schedule "B" Bylaw 846, Ambulance Fees pages 1 of 1, dated February 22, 2011.


3.0 EFFECTIVE


Bylaw No. 863, Ambulance Fees Schedule "B" will come into effect on January 1, 2012.
