

THE CORPORATION OF THE TOWN OF FORT SMITH, N. W. T.

By-Law 34-74

A BY-LAW OF THE CORPORATION OF THE TOWN OF FORT SMITH TO REGULATE AND CONTROL THE USE OF FIREARMS AND FIREWORKS WITHIN THE TOWN LIMITS PASSED PURSUANT TO SECTION 163.b OF THE MUNICIPAL ORDINANCE BEING CHAPTER 73 OF THE REVISED ORDINANCES OF THE NORTHWEST TERRITORIES 1956 AS AMENDED

WHEREAS the indiscriminate use of firearms and fireworks within the Town Limits is dangerous to the lives and property of the Town's citizens,

NOW THEREFORE The Corporation of the Town of Fort Smith at a duly constituted meeting hereby enacts as follows:

1. This By-Law shall be known as the "Firearms and Fireworks Control By-Law".
2. Firearms shall not be discharged within the Corporate Limits of the Town of Fort Smith, except
  - a. By an officer of the Royal Canadian Mounted Police or other duly authorized law enforcement officer,
  - b. By a Dog Catcher duly appointed by Council, or
  - c. In an area designated by Council as a Shooting Range or Practice Area.
3. Loaded firearms, being one with a live shell in the breach or chamber, shall not be transported or carried within the Town Limits with the same exceptions as noted in Section 2. above.
4. Fireworks, Squibs or Crackers shall not be set off or discharged within the Town Limits unless
  - a. The Supervisor has taken a "Fireworks Supervisor's Course" as given by the Federal Government, and
  - b. The Supervisor has a written permit from the Town of Fort Smith's Fire Chief, such permit to be issued separately for each date of discharge.
5. Failure to comply with any of the provisions of this By-Law shall result, upon summary conviction, in a fine not exceeding One Hundred Dollars (\$100) and imprisonment not exceeding One (1) Month or both such fine and imprisonment, as decided by a Justice of the Peace.
6. This By-Law shall come into force and take effect from the date of Third Reading thereof.




