By-Law 26-79

A BY-LAW OF THE CORPORATION OF THE TOWN OF FORT SMITH IN THE NORTHWEST TERRITORIES TO PROVIDE FOR THE NAMING OF ROADS WITHIN THE WESTGROVE SUB-DIVISION, PASSED PURSUANT TO SECTION 184. (k) OF THE MUNICIPAL ORDINANCE, BEING CHAPTER M-15 OF THE REVISED ORDINANCES OF THE NORTHWEST TERRITORIES 1974, AS AMENDED.

 $$\operatorname{\mathtt{WHEREAS}}$ the Westgrove Sub-division is developing in an orderly manner

AND WHEREAS the property owners now wish to have the roads within the Sub-division named to provide for proper mailing addresses

NOW THEREFORE the Council of the Corporation of the Town of Fort Smith, in the Northwest Territories at a duly assembled meeting enacts that the names of roads within the Sub-division be as follows

1. DEFINITIONS

a) ROAD - means and includes a street, avenue, crescent, parkway, court, or other passageway designed and intended for, or used by the general public for the passage of vehicles.

2. NAMES FOR ROADS

a) <u>"Winter Street"</u>

Being that road shown in plan of survey number 1260 commencing at the intersection between Lots 963 and 1003 Plan 1260 on "Field Street" and thence in a westerly and north westerly direction to, and terminating at, the intersection with "Wanderingspirit Street" as shown in red on the Plan of Sub-division attached to and forming part of this By-Law as Appendix 'A'.

b) "Walters Court"

Being that dead end road shown in plan of survey number 1260 that intersects with "Winter Street" between Lots 973 and 967 Plan 1260, as shown in red on the plan of Sub-division attached to and forming part of this By-Law as Appendix 'A'.

c) <u>"Wanderingspirit Street"</u>

Being that road shown in Plan of survey number 1260, commencing at the intersection of "Whitford Road" between Lots 982 and 983 Plan 1260, thence in a south, then southeasterly and then westerly direction to intersect with "Wilderness Road" as shown in red on the plan of Sub-division attached to and forming part of this By-Law as Appendix 'A'.

d) <u>"Wabasca Court"</u>

Being that dead end road shown in Plan of survey number 1260, that instersects with "Wanderingspirit Street" between Lots 986 and 992 Plan 1260, as shown in red on the plan of Sub-division attached to and forming part of this By-Law as Appendix 'A'.

e) "Whitford Road"

Being that road shown in Plan of Survey number 1260 commencing at the intersection between Lots 949 and 953 on Field Street, thence in a Westerly direction curving to a southerly direction to intersect with "Wanderingspirit Street" at a point approximately sixty one metres (61) due east of "Wilderness Road" as shown in red on the Plan of Sub-division attached to and forming part of this By-Law as Appendix 'A'.

3. This By-Law shall come into force and take effect with the date of Third Reading thereof.

READ a SECOND TIME this 23rd day of October, 1979.

READ a THIRD TIME this 18th day of December, , 1979.
