c. Briefing Note – Pool Assessment Update

Administration stated that there were three quotes received regarding the assessment of the pool. There is currently no budget allocated to this.

Cr. Couvrette stated that this was considered a reasonably urgent item several months ago and the problem has not disappeared, we have been fortunate to not have to close down the pool. Cr. Couvrette believes that Council should move forward with the assessment, looking at what it is going to cost and what needs to be done for a long-term solution to the 20 year old swimming pool.

Cr. Couvrette asked if the funding could possibly be allocated to the Gas Tax or to look at other avenues.

#### 8. Other Business

#### a. Cemetery

Mayor Daniels questioned how can we fix it, it is not getting mowed enough. We most likely need more summer SEED programs. Asked if we could get kids from the travel club to cut the grass and then we can put away three to four thousand dollars for them. Our municipal staff has too much on their plate to be able to manage the cemetery. There are other people in the community that can do this.

D/M Korol stated that there is no longer a travel club with schools anymore. Questioned if Mayor Daniels had any luck with asking Leadership about getting their summer students to help and questioned the cemetery fence.

Mayor Daniels stated that he did not get anywhere with having Leaderships summer students taking on the cemetery and the fence is still here, it is up to Council with what we want to do with it.

Cr. Couvrette supports the idea how Mayor Daniels is looking at it, having groups take on the minor maintenance responsibilities. We give a lot of funding through our donations program, part of our review of the donation policy should include the requirement of these groups to partake in community services to receive the donation allowing the items falling through the cracks like mowing the cemetery and picking up garbage out of the ditches can get done. Other things could be assisting our summer staff with events like Canada Day.

Administration stated that the idea of having the community invested and involved with some of these is a great idea however, we do have to be careful around things like paying other people to do the work as it would go against the collective agreement. With regards to having community organizations that are receiving donations from us that are already running programs, clubs, or events, it should be noted that we should not underestimate or undervalue the contribution they are already making to the community. The money that is being donated and the work that they are already doing, it takes a lot from the volunteers. Knowing how much work goes into planning programs, clubs, or events Administration would advise caution around putting on additional expectations.
