Cr. Tuckey stated that there are cars that are just going too fast causing dust to spoil everything no matter the time of day.

Mayor Daniels supports the idea, however, questioned the money for it and possibly waiting until next year.

D/M Korol questioned why dust control is not being done. Administration stated that she would look into it.
