FORT SMITH POLICING REPORT February 2022



Fort Smith RCMP Detachment G Division Northwest Territories





The Fort Smith RCMP Detachment responded to a total of 136 calls for service to the Town of Fort Smith during the month of February 2022.

Community Action Plan (C.A.P.) Community Priorities Initiatives:

The current fiscal year priorities Initiatives are identified as:

- 1) Road Safety
- 2) Police / Community Relationships
- 3) Reconciliation & Youth

1) This month the detachment addressed the issue of Road Safety by:

This initiative is enforcement based – focusing on road safety through targeted enforcement activities (checkstops, stopping vehicles leaving licensed establishments, etc.), and also by investigating complaints made by members of the public. Police received five reports of possible impaired drivers from members of the public during the month of February. Police were unable to locate the vehicle or charge the driver in all instances.

Police conducted one targeted enforcement action over the month. Targeted enforcement includes monitoring intersections for violations, conducting radar enforcement in reduced speed zones, and monitoring vehicles leaving local liquor establishments.

The Community assisted the priority by: reporting suspected impaired drivers to the RCMP

2) This month the detachment addressed the issue of Police / Community Relationships by:

This initiative is focused on maintaining good communication with our community partners (governments, partner agencies, etc.). This includes attending meetings, the sharing of information, and RCMP involvement in community activities.

February 15th – Sgt. PETERS attended the monthly Town of Fort Smith council meeting

The Community assisted the priority by: Inviting RCMP to attend meetings and participate in activities







3) This month the detachment addressed the issue of Reconciliation & Youth by:

This initiative is focused on building and strengthening relationships with our Indigenous Communities. This will be done through activities focusing on Reconciliation, and involvement with youth activities. We are actively seeking input from our community partners on how we can better interact with youth, and also what activities we can undertake in the spirit of reconciliation.

February (month) – Cst. GIBSON coached youth hockey 3 times during the month

February 15th – Sgt. PETERS and Cst. NADEAU attended Trailcross for a delicious lunch with staff and residents.

The Community assisted the priority by: Invitation from members of local governments & partner agencies for RCMP to meet with them.

Notable Occurrences for the Month:

February 4th – Police responded to a report of an alarm at the ENR office on Highway 5. A window had been smashed, and a storage shed was entered.

February 5th – Report of a break and enter into the Town of Fort Smith compound on King St. A side by side was stolen and later recovered.

February 8th – An individual who was on a curfew was observed by a Probations worker at a local business. A 29 year old man from Fort Smith was later charged with failing to comply with conditions of his release order.

February 9^{th} – Police received a report from a local resident of a scam through what appeared to be an online dog rescue. The individual lost around \$800 to unknown scammers. The investigation is continuing.

February 10th – A 29 year old man from Fort Smith was charged with mischief and failing to comply with conditions of a release order after a report of a hammer being thrown through a window at a residence. He was released pending a future court appearance.

February 16th – A break and enter was reported at the Fort Smith Motor Vehicle / Infrastructure office. Entry was gained through a window. Some items and cash were taken. The investigation is continuing.

February 18th – Fort Smith RCMP received a report of a break and enter to a residence on Field Street. Some cash and personal items were stolen. The investigation is continuing.

February 21st – A report was received of a break and enter into the Town of Fort Smith compound on King St. A truck was stolen and the suspect(s) were involved in a break and enter into the Smith's





Landing First Nation office in Bordertown. The truck was recovered with minor damage. The investigation is continuing.

February 23rd – A warrant of apprehension was issued by Fort Smith Offender Management (probations) for a 17 year old male from Fort Smith.

February 23rd – A 17 year old male from Fort Smith was found to be in violation of his court imposed conditions. A warrant was later obtained for his arrest.

February 26th – Police received a report of female being "bear sprayed" near a residence in Fort Smith. A warrant was later obtained for the arrest of a 17 year old male from Fort Smith.

The Fort Smith Detachment responded to a total of 6 complaints under the Mental Health Act involving individuals who had threatened harm to themselves. These types of complaints are very time sensitive and require immediate attention as to mitigate the potential harm. It typically results in the RCMP apprehending the individual and escorting them to the hospital for assessment by medical professionals.

There were a total of 4 calls for service related to missing person(s) or well being checks. These types of files are typically very labour intensive as they have the potential to be very serious and thus a significant amount of effort is put in at the onset of a complaint being received. All 4 calls had a positive outcome.

There were 7 calls for service relating to assaults and 1 call for service involving assault with a weapon or causing bodily harm. 1 of these files resulted is still under investigation with charges pending

A reminder that community Territorial Court circuits have been canceled for the first part of 2022 due to ongoing COVID-19 concerns. The next scheduled court circuit for Fort Smith is March 29 - 31, 2022 in Fort Smith.

BRIEFING NOTE

Subject: Multihog

Purpose:

As identified in the 2022 Capital Plan the process to purchase a Multihog was initiated and is now ready for award.

Background:

The Multihog was identified as piece of mobile equipment that would support efficiencies in the Municipal Works department. It was budgeted in the 2022 Capital Plan for \$250,000, from CPI.

The tender was posted on February 18, 2022, and closed on March 11, 2022, at 3pm. During this time is was determined that the model indicated in the tender document was experiencing difficulties with the attachment of the boom mower. On March 10th, 2022, the Town received an update that the model above did not have difficulty with the boom mower and an addendum was sent out to those who drew the tender documents. These potential proponents did not require additional time to submit the quote.

The submissions were reviewed on March 11, 2022, at approximately 3pm. Two submissions were received. One submission was local, but as the cost of the item was more than \$100,000, the 10% local purchasing policy does not apply.

The lowest bid was from Ruel Concrete for the amount of \$248,992, which is within the budgeted amount.

Recommendation:

THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH BY-LAW 1027

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH, IN THE NORTHWEST TERRITORIES, TO PROVIDE FOR THE ESTABLISHMENT OF A MUNICIPAL AND EDUCATION MILL RATE, PASSED PURSUANT TO SECTION 76 OF THE PROPERTY ASSESSMENT AND TAXATION ACT, BEING CHAPTER P-10, OF THE REVISED STATUTES OF THE NORTHWEST TERRITORIES 1988.

WHEREAS, the Council of the Municipal Corporation of the Town of Fort Smith, in the Northwest Territories, deems it to be in the public interest and is required by the provision of the Property Assessment and Taxation Act to establish Mill Rates for Municipal and School purposes; and

NOW THEREFORE, the Council of the Town of Fort Smith, at a duly assembled meeting enacts as follows:

- 1. That this bylaw may be cited as the "2022 Mill Rate Bylaw".
- 2. That assessed property in the Town of Fort Smith, liable to taxation and in respect of which grants-in-lieu of taxes may be paid, shall be liable for taxation and grants-in-lieu of taxes as follows:
