FORT SMITH POLICING REPORT April 2022



Fort Smith RCMP Detachment G Division Northwest Territories





The Fort Smith RCMP Detachment responded to a total of 161 calls for service to the Town of Fort Smith during the month of April 2022.

Community Action Plan (C.A.P.) Community Priorities Initiatives:

The current fiscal year priorities Initiatives are identified as:

- 1) Road Safety
- 2) Police / Community Relationships
- 3) Reconciliation & Youth

1) This month the detachment addressed the issue of Road Safety by:

This initiative is enforcement based – focusing on road safety through targeted enforcement activities (checkstops, stopping vehicles leaving licensed establishments, etc.), and also by investigating complaints made by members of the public. Police received six reports of possible impaired drivers from members of the public during the month of April. Police were unable to locate the vehicle or charge the driver in all instances.

The Community assisted the priority by: reporting suspected impaired drivers to the RCMP

2) This month the detachment addressed the issue of Police / Community Relationships by:

This initiative is focused on maintaining good communication with our community partners (governments, partner agencies, etc.). This includes attending meetings, the sharing of information, and RCMP involvement in community activities.

Sgt. Cormier was unable to attend to the council meeting in April. Sgt. Cormier is set to attend to the next scheduled one in May.

The Community assisted the priority by: Inviting RCMP to attend meetings and participate in activities

3) This month the detachment addressed the issue of Reconciliation & Youth by:

This initiative is focused on building and strengthening relationships with our Indigenous Communities. This will be done through activities focusing on Reconciliation, and involvement with youth activities. We are actively seeking input from our community partners on how we can better interact with youth, and also what activities we can undertake in the spirit of reconciliation.

April (month) – Members (Cpl. Leduc) continue to be involved in numerous activities in the community involving youth. (IE: Toddler time, Moms and Totts, etc).





The Community assisted the priority by: Invitation from members of local governments & partner agencies for RCMP to meet with them.

Notable Occurrences for the Month:

April 4th – Members assisted Social Services in apprehending a child that required to be relocated. The matter was dealt with no issues.

April 7th – Members received a call from a male reporting that his lugnuts were loosened overnight on his vehicle. Members attended and had no lead to investigate further. Matter was reported for information purposes.

April 7th – Members were called to a Break and Enter and the Fields Store (old location). Nothing was missing at the store, nor was there leads for members to investigate further.

April 7th – Members received a report of a fraud from an individual who attempted to purchase a cat online and never received the animal.

April 9th – Members received a call reporting someone with firearms that were not kept safe. Matter is currently before the courts.

April 9th – Members received a call to assist an individual that had a snowmobile accident at Labyrinth Lake resulting in injuries. The matter was not suspicious in nature, and subject was medically transported by helicopter.

April 13 – Members received a call from homeowners advising that a suspicious individual was knocking at doors trying to sell some jewelry. Patrols were made and the suspect was not located.

April 17th – Members received a call of a sudden death at Rennie Lake. Members attended via helicopter and assisted the Coroners office with the investigation. The matter is still under investigation.

April 30th – Members received a report of an assault causing bodily harm where an individual was assaulted with a knife. The subject was medically transported to Edmonton as a result of it. The matter is still under investigation.

The Fort Smith Detachment responded to a total of 15 complaints under the Mental Health Act involving individuals who had threatened harm to themselves. These types of complaints are very time sensitive and require immediate attention as to mitigate the potential harm. It typically results in the RCMP apprehending the individual and escorting them to the hospital for assessment by medical professionals.

There were a total of 11 calls for service related to missing person(s) or well being checks. These types of files are typically very labour intensive as they have the potential to be very serious and thus a significant amount of effort is put in at the onset of a complaint being received. All 11 calls had a positive outcome.







There were 12 calls for service relating to assaults and 1 call for service involving assault with a weapon or causing bodily harm. 4 of these files are still under investigation with charges pending

The Fort Smith Detachment is actively recruiting guards – specifically people who are able to work 1:00am to 9:00am. See the attached advert for details, contact the Detachment if interested.

The Fort Smith Detachment will also be looking at hiring a new detachment clerk in the near future. The advertisement has yet to be approved, and will be shared once it is completed.
