FORT SMITH POLICING REPORT March 2022



Fort Smith RCMP Detachment G Division Northwest Territories





The Fort Smith RCMP Detachment responded to a total of 138 calls for service to the Town of Fort Smith during the month of March 2022.

Community Action Plan (C.A.P.) Community Priorities Initiatives:

The current fiscal year priorities Initiatives are identified as:

- 1) Road Safety
- 2) Police / Community Relationships
- 3) Reconciliation & Youth

1) This month the detachment addressed the issue of Road Safety by:

This initiative is enforcement based – focusing on road safety through targeted enforcement activities (checkstops, stopping vehicles leaving licensed establishments, etc.), and also by investigating complaints made by members of the public. Police received five reports of possible impaired drivers from members of the public during the month of March. Police were unable to locate the vehicle or charge the driver in all instances.

The Community assisted the priority by: reporting suspected impaired drivers to the RCMP

2) This month the detachment addressed the issue of Police / Community Relationships by:

This initiative is focused on maintaining good communication with our community partners (governments, partner agencies, etc.). This includes attending meetings, the sharing of information, and RCMP involvement in community activities.

March 15th – Sgt. PETERS attended the monthly Town of Fort Smith council meeting

The Community assisted the priority by: Inviting RCMP to attend meetings and participate in activities

3) This month the detachment addressed the issue of Reconciliation & Youth by:

This initiative is focused on building and strengthening relationships with our Indigenous Communities. This will be done through activities focusing on Reconciliation, and involvement with youth activities. We are actively seeking input from our community partners on how we can better interact with youth, and also what activities we can undertake in the spirit of reconciliation.

February (month) – Cst. GIBSON coached youth hockey 5 times during the month

The Community assisted the priority by: Invitation from members of local governments & partner agencies for RCMP to meet with them.







Notable Occurrences for the Month:

March 1st – An individual reporting that his vehicle was stolen while he was inside a store. Members made immediate patrols, but were updated a short time later that the vehicle had been returned.

March 4th – an individual reporting that shots were fired on Tamarac Crescent. Members attended and investigated the matter alongside the Major Crimes Unit (MCU) out of Yellowknife.

March 4th – Report was received that Break and Enter had occurred at the local Lands office where a vehicle and firearms were stolen.

March 4th – Members received a report of a sudden death in the community. The death was deemed suspicious, and linked to the other 2 incidents (shots fired / break and enter) reported earlier in the day. The matter is still under investigation by the detachment, and MCU section.

March 4th – An individual reported a identity theft in town where a suspect attempt to apply for CERB on his behalf.

March 8th – Members received a report from the nursing station reporting that someone had attended for care with what appeared to be a stab wound. The matter is still under investigation.

March 10th – Members received a report that an individual had called the probations office and uttered threats to harm one of the staff. Subject was arrested and charged for this incident.

March 18th – Members received a report of a male that was to be medivaced had escaped the hospital. Subject was located and returned to the hospital.

March 26th – Members received a report of distributing intimate images without consent. The matter is still under investigation.

March 31st – Members received a report of an indecent exposure in the town of Fort Smith. The matter is still under investigation.

The Fort Smith Detachment responded to a total of 10 complaints under the Mental Health Act involving individuals who had threatened harm to themselves. These types of complaints are very time sensitive and require immediate attention as to mitigate the potential harm. It typically results in the RCMP apprehending the individual and escorting them to the hospital for assessment by medical professionals.

There were a total of 8 calls for service related to missing person(s) or well being checks. These types of files are typically very labour intensive as they have the potential to be very serious and thus a significant amount of effort is put in at the onset of a complaint being received. All 8 calls had a positive outcome.

There were 12 calls for service relating to assaults and 4 call for service involving assault with a weapon or causing bodily harm. 2 of these files resulted is still under investigation with charges pending

NOW THEREFORE, the Council of the Town of Fort Smith, at a duly assembled meeting enacts as follows: 1. That this bylaw may be cited as the "2022 Mill Rate Bylaw". 2. That assessed property in the Town of Fort Smith, liable to taxation and in respect of which grants-in-lieu of taxes may be paid, shall be liable for taxation and grants-in-lieu of taxes as follows:
