# THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH BY-LAW 817

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF FORT SMITH, IN THE NORTHWEST TERRITORIES, TO AUTHORIZE THE ESTABLISHMENT, LEVY AND COLLECTION OF CHARGES FOR SOLID WASTE MANAGMENT, PASSED PURSUANT TO SECTIONS 70 AND 72 OF THE CITIES, TOWNS AND VILLAGE ACT S.N.W.T, 2003, c.22.

WHEREAS, the Council of the Municipal Corporation of the Town of Fort Smith, in the Northwest Territories, deems it to be in the public interest to raise revenue to offset the costs of its solid waste collection and disposal operations, and

NOW THEREFORE, the Council of the Town of Fort Smith, at a duly assembled meeting enacts as follows;

### 1.0 SHORT TITLE

1.1 This by-law may be cited as the "Solid Waste Levy By-law."

### 2.0 DEFINITIONS

- 2.1 Premises means each single-family residential dwelling shall be considered to be one premise. For multi-premise and non-residential properties, the number of premises shall be established as follows:
  - 2.1.1. Apartments one premise per suite
  - 2.1.2. Schools one premise per 10 children
  - 2.1.3. Offices one premise per 1000 square feet
  - 2.1.4. Retail Commercial one premise per 1000 square feet (maximum of 5 units per outlet)
  - 2.1.5 Hospitals one premise per bed

- 2.1.6 Hotels/Motels one premise per two (2) rooms
- 2.1.7 Churches one premise per water meter

### 3.0 APPLICATION

- 3.1 The Municipal Corporation of the Town of Fort Smith is authorized to levy a charge of sixteen (\$16.00) dollars per month on all premises in the Town of Fort Smith.
- 3.2 The Town is authorized to levy a charge of sixty (\$60.00) dollars per bin per month for rental of garbage bins.
- 3.3 The Town is authorized to levy a charge of thirty (\$30.00) dollars per month per bin for pick-up from customer owned garbage bins.
- 3.4 All levies include two pick-ups per week. Additional bin pick-ups are available at fee of forty (\$40.00) dollars per pick-up.
- 3.5 The charges will be levied at the same time as the monthly charge for water services provided by the Town of Fort Smith.
- 3.6 The proceeds from the levy shall be used to pay costs for solid waste disposal in the Town.

### 4.0 REPEAL

4.1 That By-law #674 is hereby repealed.
